Peace of Mind: A Lifetime Commitment to Transplant Families

"I am not sure what we would have done if we had not found COTA ... this was so much bigger than we could handle on our own. COTA is truly a gift."

COTA parents Lindsey and Zach Olson of Illinois shared this powerful statement once they were on the other side of their little boy's unexpected need for a life-saving transplant. Like many COTA parents at the outset of an unforeseen transplant journey, they were singularly focused on saving their son's life. The Olson family's transplant journey is now different since Levi has a new heart and a second chance at life. Lindsey and Zach are relieved. They are also quite grateful for the peace of mind that comes with COTA's guiding principle ... to remove the financial barriers to a life-saving transplant by providing fundraising assistance and family support.

Peace of mind. The Olson family received peace of mind thanks to the gift of life beating in Levi's chest. The Olsons acknowledged COTA was also a gift. As a parent or grandparent, what more could you ask for ... or dream about ... when a child you love faces an unexpected crisis of any kind, let alone a transplant. Each year, COTA's Impact Report focuses on those families we have helped throughout the year and the Miracle Makers, like you, who help us stand by our commitment that no child, teen or young adult is excluded from an organ or tissue waiting list due to lack of funds. Your support of COTA, combined with state-of-the-art medical care at transplant centers throughout the nation, is a formidable, life-saving force. It is something our transplant families desperately need during what can be extremely dark and hopeless moments in their journeys. Your gifts ... your prayers and emotional support ... are the reason many COTA parents can breathe easier in the moment, and ultimately find peace of mind.

I recently had a welcome call with a new transplant mom who had made the decision to join the COTA family. I learned her son was waiting for a life-saving heart transplant; she was at his bedside when I reached her. She told me her son had been inpatient for several weeks. She was becoming frustrated and fearful about him being confined to a hospital room due to the rapidly deteriorating condition of his heart. I could hear the fear and angst in this mother's voice, and also in dad's voice when he continued the call with me because his wife was no longer able to speak about their desperate need to find a heart. Time was running out for this family. I listened intently to them both and then shared the journey of a COTA family whose son had recently received a new heart and a second chance at life. That family's journey had also been filled with fear and desperation, but I was able to share they are now in a much different place. A perfect donor heart was found, and they made it to the other side of transplant without losing their home or wiping out their savings.

After a few moments, this mom got back on the phone with me. I could sense in her voice that hope was returning with each word we exchanged. This family was not alone, although it can feel that way when a hospital room is your home for days ... or weeks ... or months while anxiously waiting for the call that an organ has been found. She asked a few questions and with each answer I gave, it was clear to me hope was breaking through their darkness. She started clinging to the possibility that her child's transplant outcome might be as positive as Levi's has been. And she and her husband might, at some point in the future, also find peace of mind.

Peace of mind is a priceless gift for a transplant family in the midst of an unthinkable crisis, learning your child might not survive unless an organ or tissue match is found. Waiting for days ... or months ... or longer as your child lies in a hospital bed getting weaker each day. Sitting in a room filled with machines, tubes and monitors that are all keeping your infant alive. Wondering when the phone will ring with the news you are longing to hear about your toddler — whose bedside you rarely leave. Going through the mail and literally falling to your knees when, with each envelope you open, your family's debt load increases exponentially. Or sitting in a

"When you hear your child needs a transplant, there is initial shock and then your mind starts digging into specifics. How the medical bills will be paid is a big worry. COTA allowed us to focus on Levi and his needs while friends and family focused on fundraisers and raising awareness. 

PLANNED GIVING

Planned or estate gifts have made

a tremendous impact on COTA and our families. In fact, over the past six years more than \$2 million has been generously provided to help COTA kids and families through these incredible supporters and their gifts.

Planned gifts will continue to have an impact as Miracle Makers notify us of their estate plans. One such plan was put in place by COTA Board Member, JoEllen Baldwin. For more than a decade, JoEllen has been



associated with the Children's Organ Transplant Association (COTA) Board of Directors and its President's Advisory Council.

"Some time ago Michael Ford, a long-time COTA Board Member, approached me about joining COTA's Board of Directors," JoEllen remembered. "He and I have been friends at work for years and have been friends personally since our children were in preschool. Michael introduced me to COTA's President, Rick Lofgren, and the rest is history."

JoEllen explained that she and her husband, Tim, were raising a young son who had developmental struggles so they found themselves as young parents searching for professionals who could help. JoEllen and Tim quickly learned this was not going to be easy and stumbled as they attempted to discover where they could turn for help. She said, "There is nothing more terrifying as a parent than having a child who is sick or compromised in any way and you do not know where to find help. You feel so powerless at a time when you need to be on top of everything but are instead being pulled under by the weight of the unknown." JoEllen's son was grown and out of high school when Michael approached her about getting involved with COTA. JoEllen remembers she was volunteering for their church and had been involved with the Big Sister Program, but she was ready for something new to add to her 'empty nester' chapter. Michael opened the COTA conversation with JoEllen by describing how COTA helps transplant parents who are navigating unknown waters ... families who JoEllen could instantly relate to in terms of wanting the best for a child but not knowing where to turn. "Once I heard about the safety net COTA provides, I was instantly impressed — especially with the peace of mind COTA gives to parents of very sick kids, teens and young adults."

JoEllen was a higher education space planner for more than three decades before she retired in late 2023. Twenty-three years of that time was spent doing space management projects at Indiana University in Bloomington, Indiana, which is also home to COTA. JoEllen said, "Once I started learning more about COTA's incredible work with a nationwide network of transplant families, I was very surprised to discover this amazing organization was headquartered in my hometown of Bloomington."

When COTA's Rick Lofgren reached out to JoEllen about serving on COTA's President's Advisory Council, she did not hesitate to get involved. In 2017, she was honored to be asked to join COTA's Board of Directors where she is now in her second, three-year term of service. When asked about a specific COTA family or child who has left an indelible mark on her heart, she readily talks about a family who shared their journey at a COTA Board Meeting. JoEllen remembers, "COTA's Harvey family, at the time of the presentation, had three children. Their son, Noah, needed a life-saving transplant. As his mother, Susan, shared their story Noah was running around the room full of energy and smiles. Susan talked about one disappointment after another ... an infection, a medication reaction, insurance challenges, never-ending bills ... and then she talked about COTA being their lifeline. Sadly, I was devastated to learn Noah passed away a few months after listening to their story and watching him run around the room."

Throughout her years of service to COTA, JoEllen has learned COTA parents fight hard yet sometimes the battle ends in tragedy. But there are also victories and blessings to celebrate. While talking about this emotional contrast JoEllen said, "There is absolutely no better nonprofit organization I could have become involved with."

Given that sentiment and JoEllen's professional role as a planner, it is not surprising that she decided to make a provision in her estate plan to help COTA families well into the future. She said, "My husband had been talking for a number of years about his estate plans. After I learned Noah had died after fighting so hard, I began to think about how I could help families like his. So, when I updated my estate plan, I committed to sharing part of my estate with COTA."

When asked if she had any words of encouragement for others who might be considering including COTA in their estate planning process, JoEllen said, "Every donation to COTA makes a difference in the life of a child who needs a life-saving transplant. Every donation contributes to a transplant family's hope for good health. My advice? Donate what you can when you can to COTA and give HOPE to these amazing families."
