

IN NEED OF A LIFE-SAVING TRANSPLANT. COTA PROVIDES VOLUNTEERS WITH FUNDRAISING ASSISTANCE AND
SUPPORT, PAYS PATIENT TRANSPLANT RELATED EXPENSES, AND PROVIDES PUBLIC EDUCATION REGARDING ORGAN
AND TISSUE DONATION. IN THE CURRENT YEAR, COTA PAID OVER 3.9 MILLION DOLLARS OF TRANSPLANT
